To All UOMA PE Collectors,

At the October 24, 2019 Board of Directors meeting, based on the market findings, the Directors approved a motion to increase Return Incentives. Although the agreement between the collectors and UOMA PE requires a 90-day delay between sharing a notice to the collectors and the coming into force of such a motion, we believe that you will accept that this motion comes into effect on January 1, 2020.

The motion provides for an increase in the Return Incentives paid to collectors on used **oils**, used plastic **containers** and used **glycols**.

We ask you to add to your signed copy of the Collectors Agreement the update of the attached Annex 1.

Also attached is the document *Increase in return incentives as of January 1st, 2020* on which you will find TABLE <A> with the Return Incentives currently in effect that will apply to all your collections made on or before December 31, 2019 and TABLE with the subsidies that will apply to all your collections made on or after January 1, 2020.

IMPORTANT: To all collectors who submit their Return Incentives claims in paper format, please note that you will find on our website for each product affected by the Return Incentives increase, a claim form for your 2019 collections and a form for your 2020 collections. It will be important to use the claim form corresponding to the date of your pick-up when making your requests.
