



ANNUAL FILTER PROMOTION
From January 1st to December 31st
for Collection Facilities registered with UOMA PE

As an appreciation for registering with UOMA PE as a Collection Facility, and to encourage you to increase your **filter** collections, UOMA PE has implemented a PROMOTION on filters.

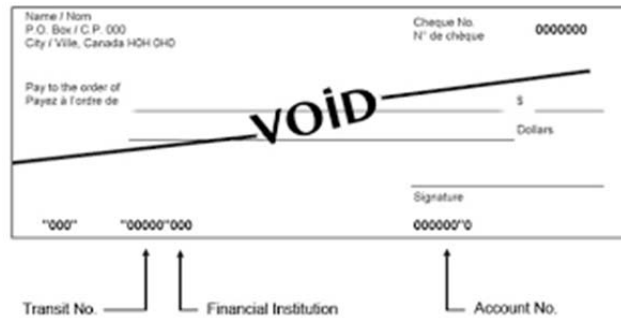
UOMA PE will pay Collection Facilities subsidies (RIs) based on the amount of filters (by weight) collected by UOMA PE’s registered Collectors. **Claims must be submitted directly to UOMA PE**, as per the Collection Facilities preference, on either a quarterly, semi-annually or annual basis within thirty days of the chosen time frame, by completing the claim form (attached) and that you will find on our website at www.uoma-atlantic.com (Prince Edward Island) in the *Collection Facilities section, subsection *Promotion on filters. In any case, the report, including the month of December 2018 must be received by UOMA PE before January 30, 2019.

Applicable products	Used oil filters collected by UOMA PE registered Collectors
***Subsidies	\$0.20/kg of filters , paid directly to the Collection Facility upon UOMA PE’s receipt of claim

*** Due to the difficulty of weighing a recycling bin, Collection Facilities using bins of 205 Liters or receptacles on wheels with either a 240 Liters or a 360 Liters capacity proceed with fixed rates that represent the average weights according to the container size multiplied by \$0.20/kg. The fixed rates are as follows: **\$20.00 per 205 Liters bin, \$28.00 per 240 Liters bin and \$34.00 per 360 Liters bin.**

There is no change in your collections. Continue to do business with the same Collector(s) and use the document(s) they provide to submit your claim according to your preferred schedule: Quarterly (3 months), bi-annually (6 months) or annually.

Furthermore, you can receive your payment by electronic funds transfer by adding a sample check to your claim form. It's an ecological reliable and faster way to receive your payment while saving time.



UOMA PE has been operational since April 2015 and pays financial incentives to UOMA PE registered Collectors for the collection of all products governed by the **Material Stewardship and Recycling Regulation – Environmental Protection Act**.

Many generators (over 29 garages and IWMCs) have registered as Collection Facilities; places where the general public and small enterprises can drop off used oil, used oil filters, used containers of oil and antifreeze (containers of 50 liters or less) as well as aerosol lubricant and aerosol brake cleaner containers governed by the Regulation, at no charge, during advertised hours.
